The individual may not participate in the public comments on the matter."

On Item 9, page 5, under <u>Proceedings</u>, shall be changed to read "No person other than the applicant or his/her official representative may address the Board during the Board's

deliberations and vote on that application. Provision is provided at the end of each meeting for brief [three (3) minute maximum] public comments.

On a motion to adopt the changes made to the By-laws by Chair DeWolff seconded by Mr. Hislop, the motion carries by consent of the Board, Aye-6 No-0 Absent-1 (Wrisley)

- Mr. Stransky would like the board to do more Informal Work Sessions with potential

 advance of the monthly meeting.
- Mr. Hislop requests that Report of Zoning Officer is presented on a more consistent basis.
